## WHAT IS THIS PRODUCT?

#### **PURPOSE**

The management objective of the product is to seek to outperform, by means of active profiled management and over the recommended investment period, its composite benchmark: 15% MSCI World Euro closing price (net dividend income reinvested), 85% Bloomberg Euro Aggregate closing price (coupons reinvested).

The product is a French UCITS subfund.

The product promotes environmental and/or social characteristics in accordance with Article 8 of the SFDR.

The product's portfolio is composed mainly of equities and fixed-income instruments from all geographical areas.

The product's sensitivity range is between 0 and 8.

A minimum of 75% of the product's net assets are exposed to fixed-income products and a maximum of 25% of its net assets are exposed to equities.

It may invest up to 100% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.
