WHAT IS THIS PRODUCT?

PURPOSE

The investment objective of the product is to seek to outperform its benchmark index, the MSCI EMU closing (net dividends reinvested), over the recommended investment period through active management.

The product is a UCITS-type SICAV (open-ended investment company) governed by French law.

The product has a sustainable investment objective in accordance with Article 9 of the SFDR.

The product portfolio is mainly composed of equities of any issuer whose issues are denominated in euros.

At least 75% of the product's net assets are exposed to equities.

It may invest up to 10% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator:



The risk indicator assumes that you hold the product for more than five years.
