WHAT IS THIS PRODUCT?

PURPOSE

The investment objective of the product is to seek, over the recommended investment period, to achieve performance regularly in line with that of the benchmark index, the MSCI Japan closing (net dividends reinvested), expressed in euros (though not hedged against yen-vs-euro currency risk), by way of management with an ex-ante tracking error (TE) limited to 1%.

The product is a UCITS-type SICAV (open-ended investment company) governed by French law.

The product's portfolio is composed mainly of equities from the geographical area of Japan.

At least 60% of the product's net assets are exposed to equities.

It may invest up to 10% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.
