WHAT IS THIS PRODUCT?

PURPOSE

Currency

The product's investment objective, through active management over the recommended investment period, is to outperform its benchmark index, 60% JP Morgan Emerging Markets Global Bond Index (hedged in euros) net coupons reinvested + 20% JP Morgan Government Index Emerging Markets Global Composite (in euros) net coupons reinvested + 20% JP Morgan Corporate Emerging Markets Bond Index Broad Diversified (hedged in euros) net coupons reinvested, by establishing a portfolio of UCIs investing therein.

The product is a French UCITS fund, classed as bonds and other international debt securities.

The product's portfolio is composed mainly of fixed-income instruments from all geographical areas.

The product's sensitivity range is between 0 and 10.
