WHAT IS THIS PRODUCT?

PURPOSE

The management objective of the Product is, by means of active management, to slightly outperform the money market interest rates, after deduction of management fees, over the recommended investment period. If money market interest rates are very low, the yield generated by the UCITS may be insufficient to cover the management fees, in which case the net asset value of the UCITS will see a structural decline.

The product is a French UCITS fund, classed as standard money market.

The product promotes environmental and/or social characteristics in accordance with Article 8 of the SFDR.

The product's portfolio is mainly composed of bonds and money market instruments, from OECD member countries, assessed as high credit quality by the management company.

The product's sensitivity range is between 0 and 0.5.

It may invest up to 10% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging purposes is permitted for up to 100% of the net assets.

The risk indicator assumes that you hold the product for three months.
