WHAT IS THIS PRODUCT?

PURPOSE

The management objective of the product is to seek to outperform, by means of active profiled management and over the recommended investment period, its composite benchmark: 80% MSCI World Euro closing price (net dividends reinvested), 20% Bloomberg Euro Aggregate closing price (coupons reinvested).

The product is a French UCITS subfund, classified as international equities.

The product promotes environmental and/or social characteristics in accordance with Article 8 of the SFDR.

The product's portfolio is composed mainly of equities and fixed-income instruments from all geographical areas.

The product's sensitivity range is between 0 and 3.

A minimum of 60% of the product's net assets are exposed to equities and a maximum of 40% of its net assets are exposed to fixed-income products.

It may invest up to 100% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.
