WHAT IS THIS PRODUCT?

PURPOSE

The product is a French UCITS fund, classified as international equities.

This product is a feeder fund of G FUND - TOTAL RETURN ALL CAP EUROPE - OD. It will be permanently invested in its master fund and in liquidities on an ancillary basis. Its management objective is the same as that of its master fund. Its performance may be lower than that of its master fund due to its own management fees.

Reminder of the investment objective of the master fund:

The investment objective of the product is to seek to outperform the benchmark index, the MSCI Europe, net dividends reinvested expressed in euro, over the recommended investment period through active discretionary management.

Reminder of the investment policy of the master fund:

The product is a UCITS subfund under Luxembourg law, classed as equities of eurozone countries.

The product promotes environmental and/or social characteristics in accordance with Article 8 of the SFDR.

The product portfolio is composed mainly of equities from member countries of the European Union, the European Economic Area or the United Kingdom.

At least 75% of the product's net assets are exposed to equities.

It may invest up to 10% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted.

Income policy: Accumulation and/or distribution and/or carried forward.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator:



The risk indicator assumes that you hold the product for more than five years.
