WHAT IS THIS PRODUCT?

PURPOSE

The management objective of the product is, by means of active discretionary management, to protect 85% of the highest Net Asset Value of the portfolio (i.e. the highest NAV published since the creation of the subfund), excluding entry charges, and to allow the investor to participate partially in the potential performance of a dynamic asset portion exposed to the equities, fixed income and credit markets.

The product is a French UCITS subfund.

The product's portfolio is composed mainly of equities and fixed-income instruments from all geographical areas.

The product's sensitivity range is between 0 and 8.

Up to 100% of the product's net assets are exposed to equities and fixed-income products.

It may invest up to 100% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.

The risk indicator assumes that you hold the product for five years.
