WHAT IS THIS PRODUCT?

PURPOSE

The product is a Luxembourg UCITS subfund.

This product is a feeder fund of GROUPAMA AXIOM LEGACY - O. It will be permanently invested in its master fund and in liquidities on an ancillary basis. Its management objective is the same as that of its master fund. Its performance may be lower than that of its master fund due to its own management fees.

Reminder of the investment objective of the master fund:

The product's investment objective is to seek to achieve an annualised yield at least equal to the 3-month Euribor index +3%, after deduction of management fees, through active discretionary management over the recommended minimum investment period.

Reminder of the investment policy of the master fund:

The product is a French UCITS fund, classed as bonds and other international debt securities.

The product's portfolio is composed mainly of equities and fixed-income instruments from all geographical areas.

The product's sensitivity range is between 0 and 8.

Up to 110% of the product's net assets are exposed to fixed-income instruments, and a maximum of 50% are exposed to equities.

It may invest up to 10% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator:



The risk indicator assumes that you hold the product for four years.
