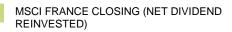

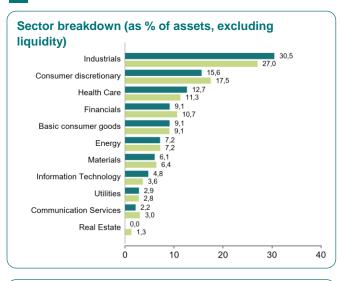

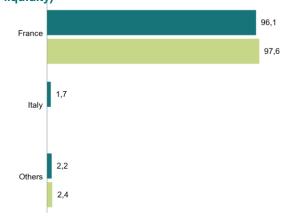

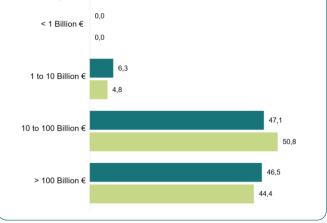






MSCI FRANCE CLOSING (NET DIVIDEND REINVESTED)

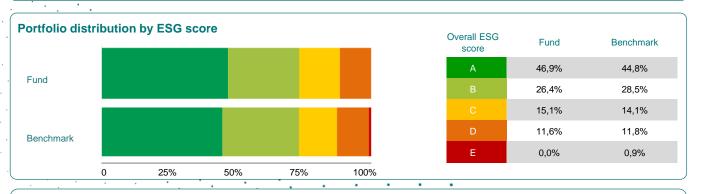
