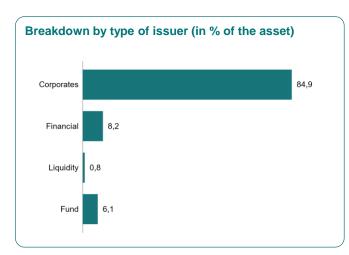

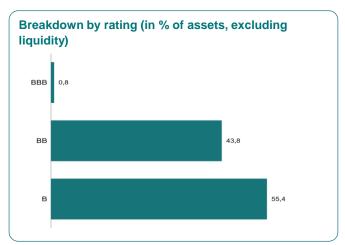

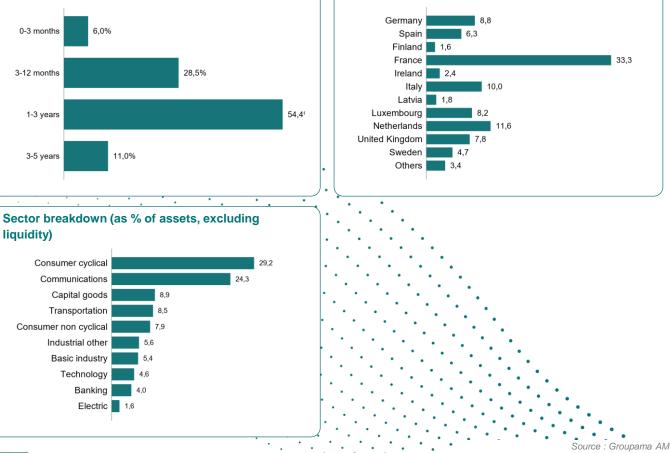


Maturity positioning (to worst)
